RECOMMENDATION AND JUSTIFICATION:

Accept the Triangle Road Construction Project as Complete and Authorize the Public Works Director to Record the Notice of Completion and Release the Retention. The work on Triangle Road has been completed by the contractor and the Public Works Director recommends acceptance of the project.


That on the 30th day of September 2014, the contract as a whole, was actually completed by said George Reed, Inc.

and the nature of the holder's interest to said roadway varies, either fee, easement, or ZOB maintenance responsibilities.


