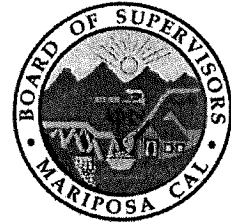

WHEREAS, JENNIFER has a love of cows and has now has quite a collection of cows which possibly stems from her early life working at Altadena Dairy; and


WHEREAS, JENNIFER has three daughters, three son-in-laws, and is anxiously awaiting two grandchildren who will be born this summer; and


