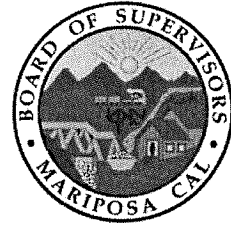

WHEREAS, DARCY has a love for fitness and a healthy lifestyle; and


WHEREAS, DARCY is leaving a huge hole in the Health Department office family, will be missed and is wished the absolute best in her new endeavor.


