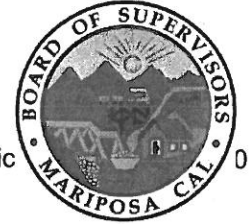

RE: First Amendment to Contract with Behavioral Health Care Sierra Vista Hospital Inc.

RECOMMENDATION AND JUSTIFICATION:

Approve the First Amendment to the Behavioral Health Care Sierra Vista Hospital Inc. Agreement to Provide Psychiatric Inpatient Services for Mariposa County Behavioral Health Increasing the Not to Exceed Amount by \$5,000; and Authorize the Board of Supervisors Chair to Sign the Amendment.

The current Behavioral Health Care Sierra Vista Hospital Inc. Agreement has a contract term running from July 1, 2014 to June 30, 2015 with a not to exceed amount of \$10,000. This Amendment will increase the amount of the original contract by \$5,000 for a total not to exceed amount of \$15,000.

To continue providing psychiatric inpatient services to Mariposa County Behavioral Health clients, it is necessary to increase the contract amount by \$5,000 in order meet ongoing clients' needs.

Funding Source: This item is funded in the Mental Health budget using Mental Health Realignment funds. There is sufficient funding available for this increase.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The existing Agreement was approved by the County Administrative Officer on July 18, 2014.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If this Amendment is not approved, Behavioral Health will have to find alternative placement for current and future clients.

FINANCIAL IMPACT:

This item is funded in the Mental Health budget 04-24 line with Mental Health Realignment funds. Previous budget actions have sufficiently funded the Inpatient Hospital line item. There is no impact to the Mental Health Services Act corrective action plan or the County General Fund.

FIRST AMENDMENT TO CONTRACT FOR SERVICES

THIS FIRST AMENDMENT TO CONTRACT FOR SERVICES is made and entered into this 19th day of May, 2015, by and between the County of Mariposa, a political subdivision of the State of California, hereinafter referred to as "**County**", and BHC Sierra Vista Hospital, Inc., hereinafter referred to as "**Contractor**".

WHEREAS, the **County** and **Contractor** have heretofore entered into a Contract dated July 15, 2014, wherein **Contractor** agreed to provide inpatient psychiatric services; and

WHEREAS, **County** and **Contractor** desire to amend said Contract to increase the maximum compensation to be paid to the **Contractor**;

NOW, THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph 4.01 "Compensation," is hereby amended to provide that an additional Five Thousand Dollars (\$5,000) will be added to the original contract maximum of Ten Thousand Dollars (\$10,000), making the total compensation paid to **CONTRACTOR** the not to exceed amount of Fifteen Thousand Dollars (\$15,000).

2. Except as herein amended, the agreement dated July 15, 2014 shall remain in full force and effect.


