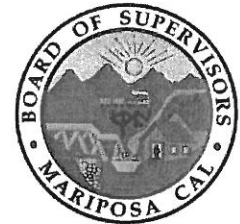

RE: 2015-16 Petroleum Product Program Cooperative Agreement

RECOMMENDATION AND JUSTIFICATION:

Approve the County Petroleum Product Program Cooperative Agreement No. 15-0179-SA for Fiscal Year 2015/2016 with the California Department of Food and Agriculture (CDFA), and authorize the Board of Supervisors Chair to sign the Agreement.

The Petroleum Product program is for work performed in Mariposa County for the inspection of petroleum distributors in the County.

The total available FY 2015/2016 contract amount for this agreement is \$1,125 - unchanged from the previous fiscal year's petroleum product program subvention amount.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The previous cooperative agreement for FY 2014/2015 was approved by Resolution No. 14-231.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Do not approve the agreement. This will prevent the subvention of any petroleum funds to Mariposa County for work performed in this program.

FINANCIAL IMPACT:

The \$1,125 State subvention for this Cooperative Agreement with CDFA is budgeted in the State Revenue account for the Agricultural Commissioner/Sealer of Weights and Measures Requested Budget for Fiscal Year 2015-16.
