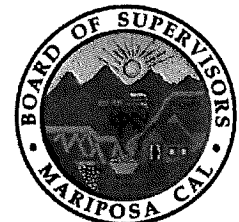

RE: Approve the First Amendment to the Contract for Services with Thunder Ridge

RECOMMENDATION AND JUSTIFICATION:

Approve the First Amendment to a Contract for Services with Thunder Ridge extending the term of the Contract to June 30, 2015; and Authorize the Board of Supervisors Chair to Sign the Amendment.

Due to an unusually late snow storm, snow plowing was required in May 2015. The contract expired on April 30, 2015.

Sufficient funds remain on the contract to pay this invoice.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On October 28, 2014 Resolution # 2014-565 was approved by the Board of Supervisors to enter into a contract with Thunder Ridge for snow removal in the Fish Camp area in the not to exceed amount of \$44,000.

Thunder Ridge has provided snow removal services in the Fish Camp area for the past several years and have been very conscientious in their efforts to remove snow in a timely manner thereby avoiding complaints

FIRST AMENDMENT TO CONTRACT FOR SERVICES

THIS FIRST AMENDMENT TO PROFESSIONAL SERVICE AGREEMENT is made and entered into this 4th day of August 2015, by and between the County of Mariposa, a political subdivision of the State of California, hereinafter referred to as "County" and Thunder Ridge Company, hereinafter referred to as "Contractor".

WHEREAS, the County and Contractor have heretofore entered into an Agreement dated October 1, 2014, wherein Contractor agreed to Snow plow in the Fish Camp Area ; and

WHEREAS, County and Contractor desire to amend said Agreement to June 30, 2015.

NOW THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph 1.01 "AGREEMENT TERM" is hereby amended to Extend the contract date to June 30, 2015.
2. Except as herein amended, the Agreement dated October 1, 2014, shall remain in full force and effect.
