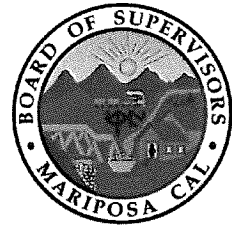

### **RECOMMENDATION AND JUSTIFICATION:**

Accept the Bondurant Mine, Dogtown and Schilling Road Projects as Complete and Authorize the Public Works Director to Record the Notice of Completion and Release the Retention. The work on these roads has been completed by the contractor and the Public Works Director recommends acceptance of the project.

### **BACKGROUND AND HISTORY OF BOARD ACTIONS:**

On September 23, 2014, Resolution No. 2014-500 authorized Public Works to enter into an Agreement with George Reed, Inc. for the reconstruction of these roads.
