RE: Authorize the Use of Health Department Vehicles for the CDC Public Health Associate

RECOMMENDATION AND JUSTIFICATION:

Authorize the Center for Disease Control and Prevention (CDC) Public Health Associate to Use the County Vehicles Assigned to the Health Department While on County Business.

The CDC Public Health Associate will function as an integral member of the Health Department. He/she will be tasked to undertake a variety of public health activities throughout the County. Several other counties in California have also been assigned public health associates and in each case this person has been granted permission to use appropriate county vehicles.

The CDC Public Health Associate must go through a background check, which will include finger printing and have a valid driver's license.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Do not authorize the CDC Public Health Associate the use of county vehicles assigned to the Health Department. Not having the ability to use a county vehicle may hamper the effectiveness of the Public Health Associate in assisting the County Health Department with its various programs.
