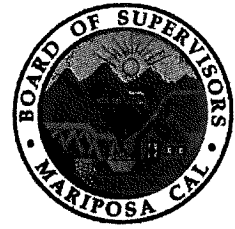

RE: Approve Extension of Child Support Plan of Cooperation with the Local Court

RECOMMENDATION AND JUSTIFICATION:

Approve the First Amendment to the Plan of Cooperation (POC) Between the Mariposa County Department of Child Support Services and Mariposa County Superior Court Extending the Term of the POC, and Authorize the Board of Supervisors Chair to Sign the Amendment. This Amendment will extend the POC through October 31, 2015.

The local Child Support Agency has been informed by State DCSS that there is a new template to be used in the POC with the Courts, however it has not yet been provided. The Local Agency has been instructed by State DCSS staff to extend the current one until an updated template is distributed.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The POC is required for both agencies to be eligible to receive State funding. The Board has approved the POC between the Local Child Support Agency and the Local Court since 2000.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Do not approve the POC and provide alternate direction to staff.

FINANCIAL IMPACT:

The POC is necessary in order for the Child Support Services Department to receive State funding. If funding is received then there is no impact to the General Fund.

THIS FIRST AMENDMENT TO PLAN OF COOPERATION BETWEEN THE LOCAL CHILD SUPPORT AGENCY AND THE SUPERIOR COURT OF MARIPOSA COUNTY is made and entered into this 26 day of August, 2015, by and between the County of Mariposa, a political subdivision of the State of California, hereinafter referred to as “**County**”, and the Mariposa County Superior Court, hereinafter referred to as “**Court**”.

WHEREAS, the **County** and **Court** have heretofore entered into a Plan of Cooperation dated June 27, 2012; and


WHEREAS, **County** and **Court** desire to amend said Plan of Cooperation to extend the term of the Plan;

NOW, THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph VI, “DURATION”, is hereby amended to provide that the Plan shall remain in effect until October 31, 2015.
2. Except as herein amended, the Plan of Cooperation dated June 27, 2012 shall remain in full force and effect.




