

1 MARIPOSA COUNTY ORDINANCE NO. 861

3 AN ORDINANCE AMENDING THE MARIPOSA COUNTY ZONING MAP
4 AND MARIPOSA TOWN PLANNING AREA SPECIFIC PLAN ZONING MAPS

5 WHEREAS, the Mariposa County Board of Supervisors adopted
6 Resolution No. 93-201 thereby initiating the public review and
7 hearing process to amend the Mariposa County Zoning Map and
8 Mariposa Town Planning Area (TPA) Specific Plan Zoning Map; and

9 WHEREAS, environmental review has been conducted on the
10 amendments in accordance with the California Environmental
11 Quality Act and the Mariposa County Environmental Review Policies
12 and Procedures adopted pursuant thereto, and an addendum to the
13 Mariposa TPA Specific Plan Environmental Impact Report has been
14 certified; and

15 WHEREAS, the Mariposa County Planning Commission and Board
16 of Supervisors have held duly noticed public hearings on the
17 amendments in accordance with State law and County Code; and

18 WHEREAS, said amendments are consistent with the Mariposa
19 County General Plan and Mariposa TPA Specific Plan.

20 NOW, THEREFORE, the Mariposa County Board of Supervisors, a
21 political subdivision of the State of California, does hereby
22 ordain as follows:

23 SECTION I

24 The property described in Exhibit "A" attached hereto and
25 incorporated herein by reference is hereby zoned as set forth in
26 Exhibit "A" as provided by Section 17.04.030 of Mariposa County
27 Code.

SECTION II



Further, the Official Zoning Map and Specific Plan Map shall be modified to reflect all properties in the Scenic Resource (SR) Zone is located in the Scenic Resource-20 Acre (SR-20) Zone.

SECTION III

This ordinance shall become effective thirty (30) days after final passage pursuant to Government Code Section 25123.
