AN ORDINANCE AMENDING SECTION 16.04.030 ENTITLED "DESIGNATION OF REMAINDER" OF CHAPTER 16.04 ENTITLED "GENERAL PROVISIONS" OF TITLE 16 ENTITLED "SUBDIVISIONS"

WHEREAS, the State of California is Section 66434 et seq of the Government Code, cited as the Subdivision Map Act establishes standards for the preparation of final maps and parcel maps, and

WHEREAS, Section 16.04.030 of the Mariposa County Code contains a requirement that conflicts with the Subdivision Map Act, and

WHEREAS, the Board of Supervisors, upon recommendation of the Public Works Department, has determined that it is in the public interest to amend the County Subdivision Code to conform with the State Law.

NOW, THEREFORE, the Board of Supervisors of the County of Mariposa, a political subdivision of the State of California, hereby ordains as follows:

SECTION I: Section 16.04.030 Subsection A. Number 2. is amended to read as follows.

2. A statement shall be placed-upon-the-face-of-all recorded in the Official Records concurrently with subdivision maps designating a remainder as follows: "A Certificate of Compliance must be obtained prior to the issuance of a development permit on the designated remainder in accordance with Section 16.03.040 of Mariposa County Code." This statement shall be referenced on the face of the map.
