

AMENDING CHAPTER 10.08 ENTITLED
"STOPPING, STANDING & PARKING"
BY ADDING SUBPARAGRAPH "J",
RELATIVE TO ANGLE PARKING
TO SECTION 10.08.030

THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:

SECTION I: Chapter 10.08 entitled "Stopping, Standing & Parking" is hereby amended by adding subparagraph "J" relative to angle parking, to Section "10.08.030 Motor vehicle parking regulations--Applicability.", to read in its entirety as follows:

"J. Angle parking shall be allowed in the following locations in the county:

1. Beginning at the intersection of the easterly line of Bullion Street with the northerly line of 10th Street; thence along said northerly line of 10th Street easterly, 100 feet.

2. Beginning at the intersection of the northerly line of 9th Street with the westerly line of Bullion Street; thence along said westerly line of Bullion Street, northerly to the southerly line of 10th Street.

3. a. Beginning at the intersection of the northerly line of 12th Street with the easterly line of Jessie Street; thence along said easterly line of Jessie Street, northerly 94 feet. b. Beginning at the intersection of the northerly line of 12th Street with the westerly line of Jessie Street; thence along said westerly line of Jessie Street, northerly, 145 feet.

4. Beginning at the intersection of the southerly line of 9th Street with the easterly line of Bullion Street; thence along said easterly line of Bullion Street, southerly, 75 feet.

5. Beginning at the intersection of the southerly line of 6th Street with the westerly line of Bullion Street; thence along said westerly line of Bullion Street, southerly, 85 feet.

6. Commencing at the intersection of the easterly line of Jones Street with the northerly line of 6th Street; thence along said northerly line of 6th Street, easterly, 42 feet to the point of beginning; thence continuing along said northerly line, 395 feet.

7. Beginning at the intersection of the easterly line of State Highway 140 with the northerly line of 4th Street; thence along said northerly line of 4th Street, easterly, 45 feet.

8. Beginning at the intersection of the easterly

line of Charles Street with the northerly line of 11th Street; thence along said northerly line of 11th Street, easterly, 104 feet."

SECTION II: This Ordinance shall become effective thirty (30) days from the date of final passage, pursuant to Government Code Section 25123.
