

MARIPOSA COUNTY ORDINANCE NO. 667

AMENDING CHAPTER 15.10 ENTITLED,
"BUILDINGS AND CONSTRUCTION", BY REPEALING AND REPLACING
SECTION 15.10.010 ENTITLED "ADOPTION OF UNIFORM CODES"
AND ADDING SECTION 15.10.030 ENTITLED,
"UTILITY SERVICE REQUIREMENTS"

THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California does ordain as follows:

SECTION I: Chapter 15.10 of the Mariposa County Code entitled, "Buildings and Construction", is hereby amended by repealing and replacing section 15.10.010 entitled, "Adoption of Uniform Codes", to read as follows:

"15.10.010 Adoption of uniform codes. The following uniform codes are adopted by reference and, except as otherwise provided in this chapter, are applicable to and shall govern all construction within the county;

A. The Uniform Building Code, latest adopted edition as amended from time to time, as adopted by the International Conference of Building Officials;

B. The Uniform Mechanical Code, latest adopted edition as amended from time to time, as adopted by the International Conference of Building Officials;

C. The National Electric Code, latest adopted edition as amended from time to time, as adopted by the National Fire Protection Association;

D. The Uniform Plumbing Code, latest adopted edition as amended from time to time, as adopted by the International Association of Plumbing and Mechanical Officials."

SECTION II: Chapter 15.10 of the Mariposa County Code entitled, "Buildings and Construction" is hereby amended by the renumbering of "Section 15.10.030 Fees set by resolution", to "Section 15.10.040 Fees set by resolution", and by the renumbering of "Section 15.10.040 Penalties", to "Section 15.10.050 Penalties".

SECTION III: Chapter 15.10 of the Mariposa County Code entitled, "Buildings and Construction" is hereby amended by the addition of Section 15.10.030 entitled, "Utility service requirements", to read as follows:

"15.10.030 Utility service requirements: No utility company or provider shall provide any electrical, power, butane, propane or natural gas service to any system in the County of Mariposa until the system has received final approval by the Mariposa County Building Department.

No utility company or provider shall provide any electrical, power, butane, propane or natural gas service to any newly constructed dwelling unless there is a street, dedicated County road or State highway address of the dwelling permanently affixed to either the dwelling itself or on the access road and individual driveway leading to the dwelling. The letters and numbers on the address shall be of a minimum height of three (3) inches and shall be placed on a contrasting backboard."

SECTION IV: This Ordinance shall become effective thirty (30) days from the date of final passage, pursuant to Government Code Section 25123.
