MARIPOSA COUNTY ORDINANCE NO. 613

An Ordinance Amending the Zoning Maps for the Unclassified and Agricultural Exclusive Zones (Not to be codified in Code Text).

WHEREAS, an application for change of zone was heard by the Planning Commission on a portion of property referred to as Assessor's Parcel Numbers 11-050-001 and 11-050-004, and a recommendation by Planning Commission Resolution No. was made that the application be granted, following a Public Hearing as required by State Law; and

WHEREAS, a Public Hearing was held by the Board of Supervisors after due notice as required by Law, and the application approved.

NOW THEREFORE, the Board of Supervisors of Mariposa County, a political subdivision of the State of California, does hereby ordain as follows:

SECTION I: Pursuant to Section 17.36.010 of the Mariposa County Code, the Official Zoning Maps of the County of Mariposa, shall be amended to remove the following described properties from the Unclassified Zone as established by Ordinance 345 and subsequent amendments, and to add said property to the Agricultural Exclusive Zone as established by Ordinance 366 and amendments thereto:

LEGAL DESCRIPTION: See EXHIBIT A attached.

SECTION II: This Ordinance shall take effect 30 days after the date of passage pursuant to Government Code Section 25123.
