

MARIPOSA COUNTY ORDINANCE NO. 621

AN ORDINANCE DECLARING INTENTION TO ESTABLISH AND MAINTAIN  
A MUSEUM OF HISTORY, SCIENCE, ART AND SIMILAR OBJECTS  
BY ADDING CHAPTER 2.88 ENTITLED "ESTABLISHMENT AND  
MAINTENANCE OF MARIPOSA COUNTY MUSEUM OF  
HISTORY, SCIENCE, ART AND SIMILAR OBJECTS",  
PURSUANT TO CALIFORNIA PUBLIC RESOURCES CODE SECTIONS  
5120 TO 5138 INCLUSIVE

THE BOARD OF SUPERVISORS of Mariposa County, a political  
subdivision of the State of California, does hereby ordain as  
follows:

SECTION I: Title 2 of Mariposa County Code is hereby amended  
by adding Chapter 2.88 to read in its entirety as follows:

"CHAPTER 2.88

ESTABLISHMENT AND MAINTENANCE OF MARIPOSA COUNTY  
MUSEUM OF HISTORY, SCIENCE, ART AND SIMILAR OBJECTS

SECTIONS:

2.88.010 Purpose and Authority.

2.88.020 Intention to Cooperate with Other Agencies

2.88.010 Purpose and Authority.

A. The County of Mariposa does hereby declare its inten-  
tion to establish and maintain a museum and to encourage the  
establishment, operation and maintenance of other museums of  
history, science, art and for similar objectives in and for  
the County of Mariposa.

B. This chapter is enacted pursuant to the provisions of  
California Public Resources Code Section 5120 to 5138 inclusive.

2.88.020 Intention to Cooperate with Other Agencies.

A. It is hereby declared that it is the intention of  
Mariposa County to cooperate with other agencies, both public and


1 private, who desire such cooperation in the establishment,  
2 operation, and/or maintenance of aforementioned museums located  
3 within the geographic boundaries of the County of Mariposa.

4 B. It is further declared that the purpose of such cooper-  
5 ative arrangements is to facilitate and promote the development  
6 of the County's cultural assets through the efforts of private  
7 individuals and organizations as well as other public agencies  
8 for the benefit of residents and visitors of the County."


9 SECTION II. This Ordinance shall become effective thirty (30)

11 Section 25123.
