An Ordinance Amending the Zoning Maps for the Exclusive Agricultural and Unclassified Zones (not to be codified in Code text).

WHEREAS, an application for change of zone was heard by the Planning Commission on the property referred to as APN 3-170-17 and a recommendation by Planning Commission Resolution No. 84-20 was made that the application be granted; and

WHEREAS, a public hearing was held by the Board of Supervisors on June 12, 1984 after due notice as required by law, and the application approved.

NOW THEREFORE, the Board of Supervisors of Mariposa County, a political subdivision of the State of California does hereby ordain as follows:

Section I:

Pursuant to Section 17.06.010 of the Mariposa County Code, the official zoning maps of the County of Mariposa shall be amended to remove the following described property from the Exclusive Agricultural Zone as established by Ordinance No. 366 and subsequent amendments thereto, and to add said property to the Unclassified Zone as established by Ordinance No. 345 and subsequent amendments thereto;

Section II:

In the event that the County of Mariposa adopts a Zoning Ordinance for the purposes of implementing the Mariposa County General Plan; the subject property shall be rezoned in accordance with the General Plan Land Use Classification applied to the property at the time of the effective date
