MARIPOSA COUNTY ORDINANCE NO. 638

AN ORDINANCE AMENDING THE ZONING MAPS FOR THE RESIDENTIAL ZONE AND UNCLASSIFIED ZONES (not to be codified in Code Text).

WHEREAS, an application for change of zone was heard by the Planning Commission on the property referred to as Assessor's Parcel Number 013-090-008 and a recommendation by Planning Commission Resolution No. 85-4, was made that the application be granted; and

WHEREAS, a public hearing was held by the Board of Supervisors on April 23, 1985, after due notice as required by law and the application approved.

NOW THEREFORE, the Board of Supervisors of Mariposa County, a political subdivision of the State of California, does hereby ordain as follows:

SECTION I

Pursuant to Section 17.06.010 of the Mariposa County Code, the official zoning maps of the County of Mariposa shall be amended to remove the following described property from the Residential Zone as established by Ordinance No. 180 and subsequent amendments thereto, and add said property to the Unclassified Zone as established by Ordinance No. 345 and subsequent amendments thereto.

LEGAL DESCRIPTION: Parcel 1, Map for Rilla K. Hair, Recorded in Book 3 of Parcel Maps at page 25, Mariposa County Records.

SECTION II

This Ordinance shall take effect thirty (30) days after the date of passage, pursuant to Government Code Section 25123.






