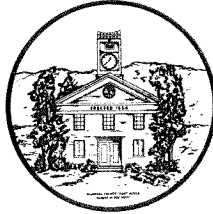

Dear Board Members:

The above two claims were received on March 20, 1992 for incidents which occurred on March 12, 1992 on Merced Falls Road. I have been informed that a temporary cold patch was placed on sections of this road which is heavily used as it leads to the Don Pedro Golf Course. This is a unique situation wherein with the heavy rains and heavy truck traffic on the road, permanent patching was necessary to repair the potholes caused by the rains and traffic. Prior to the additional patchwork being complete, however, the two incidents occurred which resulted in claims being filed.

In view of the above, my recommendation is for the Board to approve Claim No.'s C92-8 and C92-9.
