A RESOLUTION AUTHORIZING SUBMISSION OF AN
OFFICE OF CRIMINAL JUSTICE PLANNING GRANT APPLICATION
FOR CHILD ABUSER VERTICAL PROSECUTION PROGRAM FUNDS

WHEREAS, Mariposa County desires to undertake a certain project designated as the Child Abuser Vertical Prosecution Program to be funded in part from the funds made available consistent with the California Penal Code (PC) Chapter 2.4, commencing with Section 999q, administered by the Office of Criminal Justice Planning (hereafter referred to as OCJP);


NOW THEREFORE, BE IT RESOLVED that the Chairman of the Mariposa County Board of Supervisors is authorized on its behalf to submit the attached application to OCJP and is authorized to execute on behalf of the Mariposa County Board of Supervisors the attached Grant Award Agreement including any extensions or amendments thereof. The District Attorney of the County of Mariposa is authorized to submit program and fiscal information to OCJP as may be required from time to time.

IT IS AGREED that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and OCJP disclaim responsibility for any such liability.


BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.


