A RESOLUTION RECOGNIZING STEVEN A. MINDT  
FOR HIS CONTRIBUTIONS TO MARIPOSA COUNTY

WHEREAS, STEVEN MINDT has worked since November, 1990, as Mariposa's first County-paid Environmental Health Specialist; and

WHEREAS, STEVE has succeeded in the difficult balancing of enforcing applicable laws for the protection of the public health with the need to educate people about the public health issues in a non-confrontational way; and

WHEREAS, STEVE created a food-handler's course which he offered on various occasions, with good attendance, to all County restaurants; and

WHEREAS, STEVE has addressed numerous difficult cases involving public health threats to families and children at the site of their dwellings, and in so doing has balanced the need to protect adults and children from substandard conditions against the pressing need for shelter, and has continually shown patience and compassion;
