
WHEREAS, MARY is a member of the Commission on Aging, and a History Center docent--serving as May's Chairperson; and




WHEREAS, MARY says "there's always enough time" to do the things which need to be done.



WHEREAS, BUTCH officiates at the senior bingo program at the American Legion Hall every Friday; and


WHEREAS, BUTCH is an active and enthusiastic volunteer for the American Legion, VFW and Odd Fellows; and


WHEREAS, BUTCH can be depended upon to help out even with very little notice; and


