Recommend authorizing Health Officer to administer Hepatitis B Vaccine to new Volunteer Firefighters, First Responders and Sheriff's Deputies. The Board previously established policy to administer this vaccine and all currently employed medical first responders were offered vaccine. It seems appropriate to continue offering vaccine to all new personnel who perform high risk duties. We have found a new source of vaccine (federal government) at a significant cost savings.
