Approve this Resolution authorizing the Human Services Director and the Public Works Director to sign the attached Interdepartmental Agreement for bus services for GAIN participants.

On May 21, 1991, the Board meeting as the Local Transportation Commission approved setting aside \$50,000 in Local Transportation Commission funds to develop and implement a transit demonstration project to provide transportation to Merced for the general public and GAIN participants.

Public Works has developed, implemented and continues to modified the "Butterfly Express" to meet the needs of the general public and in particular, GAIN participants attending Merced College. Availability of bus service to Merced College at reasonable cost has not reduced overall transportation costs of the GAIN program, however, more participants are attending vocational & educational training programs within the same budgeted amount.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

LTC Resolution 91-1 adopted May 21, 1992 allocated projected Local Transportation fund revenues for FY 1991-92.
