RECOMMENDED ACTION AND JUSTIFICATION:

The contract period ended June 30th, and service has been discontinued. The ridership has been very low for June, compared to May, mainly due to negative publicity and the end of spring Merced College classes.

Recommend the Butterfly Express service be re-instated beginning August 17th, 1992. Merced College classes start that day, and there have been enquiries about availability.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On May 26, 1992, the Board requested Public Works return with a recommendation on the continuance of the Butterfly Express service.

LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION

If the service is not started until after the budget is finalized, there will be a loss of ridership due to students either not registering, or finding other transportation. The service would not be as successful. The service can be included in the experimental Highway 140 service.
