Do not adopt Resolution.

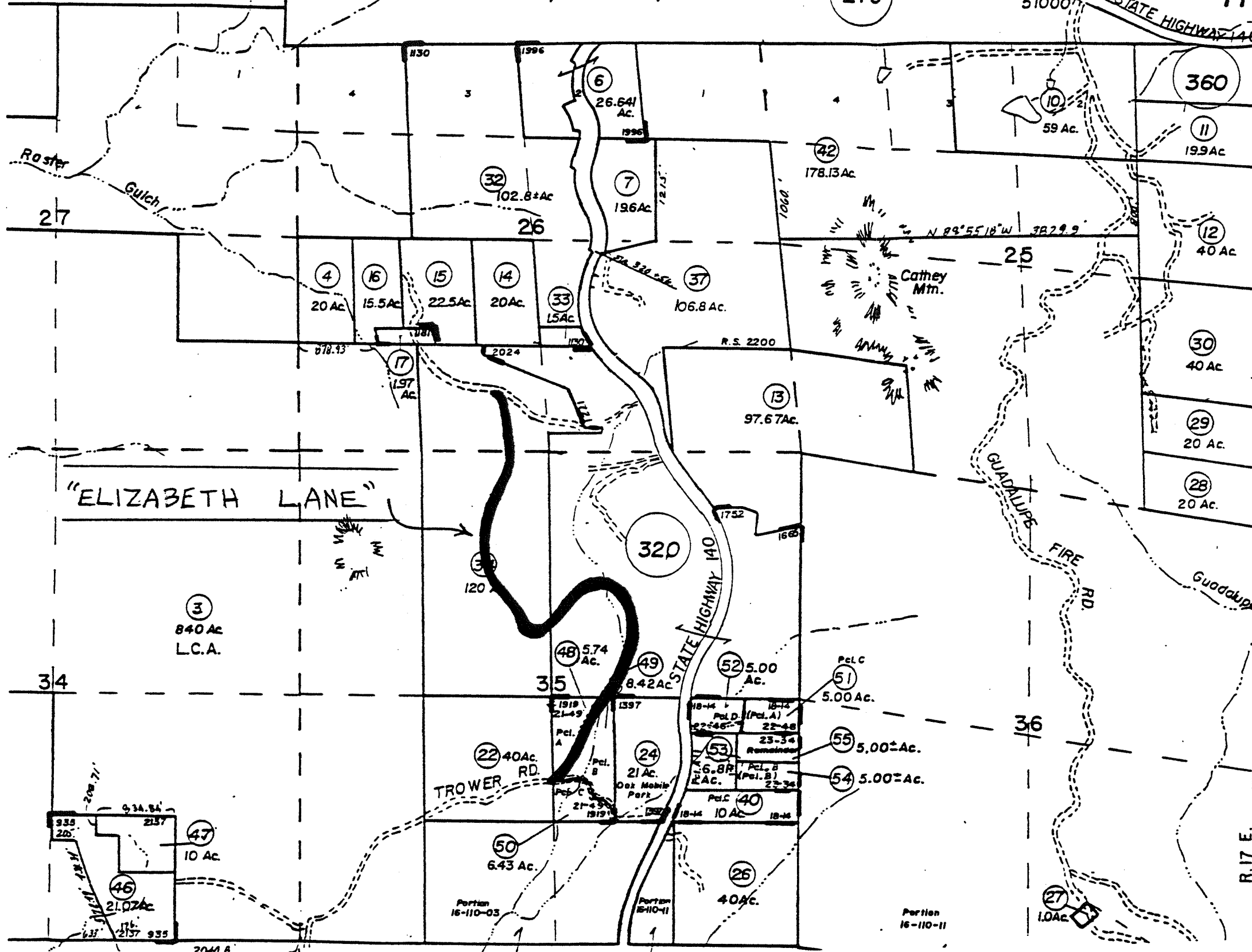

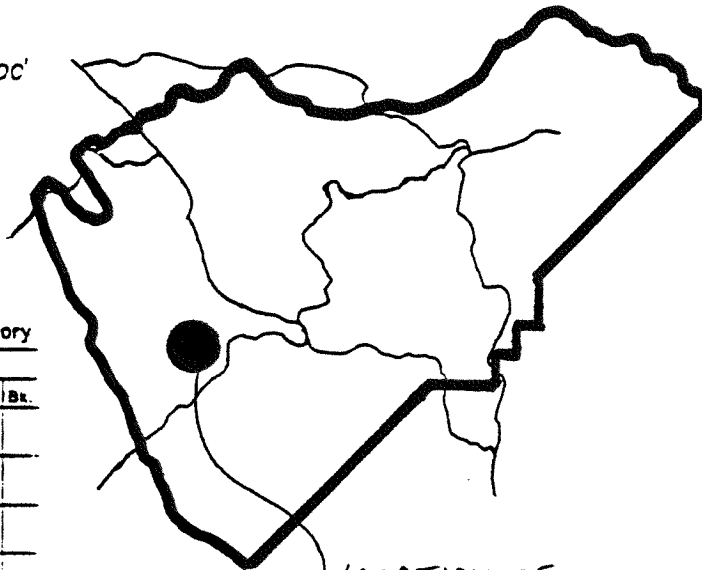
