Adopt the attached resolution pursuant to the Budget Act indicating the County Of Mariposa's intent to adopt a final budget prior to November 1, 1992.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board of Supervisors currently has statutory authority granted under the Budget Act to adopt a budget no later than September 1, 1992. By resolution, the Board of Supervisors can extend that date on a permanent basis to no later than October 1, 1992. This agenda item anticipates a legislative proposal currently under consideration at the state legislature extending that date to November 1, 1992. It is provided to the Board of Supervisors in order to ensure that the latest possible date is available to the County if the legislation passes.

LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

1. If the resolution is not adopted to extend the budget, the County is required to adopt a budget by September 1, 1992.
2. Adopt the resolution extending the period to October 1, 1992 only.



RESOLUTION OF THE
MARIPOSA COUNTY BOARD OF SUPERVISORS
EXTENDING THE FINAL BUDGET ADOPTION DATE TO
NOVEMBER 1, 1992

WHEREAS, the Board of Supervisors of Mariposa County has adopted a proposed budget for FY 1992/93 which is balanced; and

WHEREAS, the Mariposa County Board of Supervisors is awaiting state action on the State Budget prior to finalization of the County budget; and

WHEREAS, the state legislature has been unable to adopt a budget for forty nine (49) days;

NOW THEREFORE BE IT RESOLVED that the Board of Supervisors of the County of Mariposa extends the Mariposa County budget adoption deadline from September 1 to the current statutory authorization of October 1; and

BE IT FURTHER RESOLVED that the Board of Supervisors of the County of Mariposa extends the filing deadline for the Mariposa County final budget to the clerk of the board and the office of the Controller from November 1 to December 1; and


BE IT FURTHER RESOLVED if the state legislature extends said deadline to November 1, 1992, that Mariposa County's budget adoption and filing deadlines will similarly be extended.
