

A RESOLUTION SUPPORTING THE EFFORTS OF THE CITY AND COUNTY
OF SAN FRANCISCO TO KEEP THE SAN FRANCISCO GIANTS IN CALIFORNIA

WHEREAS, THE SAN FRANCISCO GIANTS have played baseball in San Francisco since 1958; and

WHEREAS, THE GIANTS are an historically important franchise in the National League and in Major League Baseball; and

WHEREAS, the benefits of having a professional baseball team extend to areas outside of the city in which the team plays, by the development of team rivalries, increased tourism, and the advantages of having a strong and thriving group of professional teams in one state; and

WHEREAS, THE GIANTS have a fan base stretching throughout California, giving pleasure and entertainment to many fans who follow the team by radio and television if not in person; and


WHEREAS, Major League Baseball will soon vote on whether to approve the sale of THE SAN FRANCISCO GIANTS to a group of Florida investors; and


