**A RESOLUTION RECOGNIZING THE FIFTY CITIZEN VOLUNTEERS
WHO BEGAN THE MARIPOSA CHAPTER OF AMERICAN RED CROSS**

WHEREAS, there has been an overwhelming volunteer response to emergency evacuation needs as a result of fire in Mariposa County over the past three years; and

WHEREAS, the need for a more organized volunteer effort has become obvious as a result of those evacuation incidents; and


WHEREAS, the advantages to Mariposa County residents and tourists of a local Red Cross Organization of volunteers has become apparent; and

WHEREAS, more than 50 citizens of Mariposa County have responded to the call to organize a Mariposa Chapter of the American Red Cross, giving of their own time for training and participation in related activities; and

WHEREAS, those citizens have expressed a willingness to be available on a moment's notice to staff an evacuation center, and to provide nursing services, family support services, disaster assessment services, replacement of personal medical supplies or emergency food services.

NOW, THEREFORE, BE IT RESOLVED that the Mariposa County Board of Supervisors, a political subdivision of the state of California, does recognize all fifty citizen volunteers who began the Mariposa chapter of American Red Cross, and extends special thanks to Bob Jones of Atwater who has come to Mariposa on numerous occasions to conduct the necessary training.
