BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Lake Don Pedro Community Service District has been required by the State Department of Water Resources to find alternate water resources. The CSD requested and received an Encroachment Permit, #2254, to drill a test well within the County right-of-way on Ranchito Road.

The test well proved successful and has been capped in anticipation of future use.

The CSD now is requesting an Encroachment Permit for a permanent well installation within the County right-of-way. The Board has the option of conditioning the permit if it so desires.


