**RECOMMENDED ACTION AND JUSTIFICATION:**

Resolution authorizing the Human Services Director to sign this agreement with Mother Lode Job Training (MLJT) for \$6397 for GAIN Basic Education. The receipt of this funding offsets GAIN funds to provide basic education and GED preparation services to GAIN participants.
