Recommend resolution authorizing Health Officer to apply for an Enforcement Assistance Grant; appropriation of \$15,778 from this grant into the Health Department budget. The State will make available to Local Enforcement Agencies this year and, they say, each year thereafter, funds to augment landfill inspection. We have done these inspections using State Sanitarians. It is justified to use these funds to offset the costs of our County Sanitarian as long as he does some landfill inspection work.


