RECOMMENDED ACTION AND JUSTIFICATION: That the Board of Supervisors rescind resolution 89-537 and approve a resolution authorizing Mountain Crisis Services to receive domestic violence services revenue generated from marriage license fees. This action is warranted because Mariposa County now has a local program providing domestic violence services. Currently, revenue from license fees is transferred to Safe House in Oakhurst and to Womens Crisis Center in Sonora.

BACKGROUND AND HISTORY OF BOARD ACTIONS: The Domestic Violence Centers Act, Chapter 5, Welfare and Institutions Code authorized an increase of marriage license fees to specifically fund domestic violence programs in accordance with this Act. The Board implemented the Domestic Violence Act by approving Resolution 81-146, October 24, 1981 and Resolution 89-537, November 24, 1989. Resolution 89-537 authorized disbursement of the funds to Mother Lode Women's Crisis Center (10% of the total) and 90% to Safe House located in Oakhurst. In January a request was made by the Chairperson of Mountain Crisis Services to earmark the marriage license fees for domestic violence programs to this agency.

Mountain Crisis services evolved from a need to provide domestic violence services to residents of Mariposa County due to significant increases of domestic violence incidents. Services are provided by a pool of trained volunteers whose primary focus is to provide support and encouragement to enable clients to utilize established resources. The program has 14 trained volunteers presently. An important component of service delivery is a fully operational 24 hour crisis hotline. The Trust fund averages around \$3,000 deposited on an annual basis.
