RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes No)
Authorize distribution of the Property Tax Administration fee of \$410,669 from the taxing entities as follows:

1. \$20,718 from the J. C. Fremont Hospital District to General Fund costs associated with ambulance service, and to assist the Hospital with economic development efforts.
2. \$373,631 from the Unified School District to Future Plant Acquisition to be utilized for the Library and other joint County/school community service efforts.
3. \$6,043 from the Mariposa Public Utility District (MPUD) to General Fund costs associated with ambulance service within the MPUD service area.
4. \$10,277 from the various Special Districts which will be refunded only on request.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On 1/22/91 the Board took action to introduce an ordinance entitled, "Public Agency Administrative Overhead Fees" and to establish the property tax administration fees for fiscal year 1990/91. This agenda item will authorize distribution of those funds when they are collected.
