

REGARDING THE DISABILITY RETIREMENT
OF WALTER THOMAS STRICKLAND
FROM THE COUNTY OF MARIPOSA
PUBLIC EMPLOYEES' RETIREMENT SYSTEM

WHEREAS, the County of Mariposa (hereinafter referred to as "AGENCY") is a contracting agency of the Public Employees' Retirement System, and

WHEREAS, the Public Employees' Retirement Law requires that a contracting agency determine whether an employee of such agency in employment in which he is classified as a local safety member is disabled for purposes of the Public Employees' Retirement Law and whether such disability is "industrial": within the meaning of such Law, and

WHEREAS, an application for disability retirement of WALTER THOMAS STRICKLAND employed by "AGENCY" in the position of Undersheriff has been filed with the Public Employees' Retirement System, and

WHEREAS, the Mariposa County Board of Supervisors has reviewed the medical and other evidence relevant to such alleged disability and determined that the disability was due to stress;

NOW THEREFORE, BE IT RESOLVED:

1. That the Mariposa County Board of Supervisors, finds and determines and it does hereby find and determine that WALTER THOMAS STRICKLAND is incapacitated within the meaning of the Public Employees' Retirement Law for performance of his duties in the position of Undersheriff, and that his condition was determined to be permanent and stationary as of November 19, 1990, and

2. BE IT FURTHER RESOLVED, that the Mariposa County Board of Supervisors, finds and determines and it does hereby find and determine that such disability is a result of stress arising out of and in the course of employment; and further determines that such disability did not result from an injury which is the direct consequence of a violent act perpetrated upon the member or did not occur during the performance of those portions of the member's duties which are particularly hazardous and dangerous, and neither said WALTER THOMAS STRICKLAND nor the AGENCY, County of Mariposa, has applied to the Workers' Compensation

Appeals Board for a determination pursuant to Section 21026 whether such disability is industrial.

3. BE IT FURTHER RESOLVED, that the effective date of disability retirement for WALTER THOMAS STRICKLAND shall be May 3, 1991.
