Approve this resolution authorizing the Human Services Director to submit a proposal to the State Department of Alcohol and Drug Programs to fund a High-Risk Youth Demonstration Project.

The Department intends to fund eight demonstration projects which provide creative and innovative approaches to drug and alcohol use prevention among high-risk youth. A total of \$549,383 is available for each project over a five year period. This amount of revenue will support enhanced services for teenagers by providing increased counseling and recreational activities.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board has looked favorably at providing increased services to youth who are in need of increased recreational outlets which promote abstinence from the use of alcohol and/or other drugs. This is evidenced by the support given to the Teen Task Force.

The County may chose to redirect existing revenues which support other program services. The County may lose an opportunity to obtain funding for unmet service needs.
