

**RECOMMENDED ACTION AND JUSTIFICATION:** (Policy Item: Yes \_\_\_ No x)

Resolution approving a new line item in Economic Development/Mining and Mineral Exhibit for Extra Help, allocating funds into that item (\$4,166), and authorizing Public Works Director to approve expenses.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:**

In order to consolidate expenses of the Mining and Mineral Exhibit within the Economic Development budget, it is necessary to create a line item for Extra Help within that budget and transfer \$4,166 from the Mineral Exhibit line item into the new Extra Help line item. When the County approved the Mining and Mineral Museum, extra help monies were administered through Public Works/Parks and Recreation budget. The consolidation of all costs of the Mining and Mineral Museum, however, should be allocated to Economic Development. Creation of this line item and transfer of funds into it from the Museum budget will accomplish this. Approval by the Board for Larry Pollard, Director of Public Works, to approve the expenses continues administration of extra help in the Public Works/Parks and Recreation Department.

**LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

1. Approve creation, transfer and authorization for Director of Public Works to administer line item.
2. Approve creation and transfer but do not authorize Director. Administrative Officer will be required to administer extra help which is less efficient.
3. Do not approve. Consolidation of costs will not be accomplished.
