**RECOMMENDED ACTION AND JUSTIFICATION:**

It is recommended that the Auditor be directed to transfer funds from the Children's Trust Account to General Contingency, from General Contingency to All Tribes Counseling Center for use in providing services to Native American children at risk of being neglected or abused.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The Board established the Child Abuse Prevention Coordinating Council as the body responsible for recommending expenditures of Challenge Grant Funds. The Coordinating Council in a regular meeting on September 19, 1990 approved transferring funds to All Tribes Counseling Center to support that Agencies efforts in providing services to Native American children at risk.

All Tribes will not receive the funds and not be able to fully provide their proposed services to Native American children in the County.
