Recommend resolution authorizing Chairman to sign Amendment #3 to Agreement MA8800-9-0003 with Yosemite National Park for Ambulance Service in El Portal; resolution authorizing payment to Yosemite National Park Service of \$20,000 for maintenance of ambulance service in El Portal during FY 1990-1991. Memorandum of Understanding No. MA 8800-9-0003 addresses this agreement between the County and Park Service. This sum is contained within the ambulance line item in Health Department budget.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board paid \$6,000 for FY 1988-1989 and \$15,000 for FY 1989-1990 for this service. The level of service is increasing with on-going personnel training.




1. The county agrees to provide to the National Park Service the sum of twenty thousand dollars (\$20,000.00) prior to March 29, 1991.




