RECOMMENDED ACTION AND JUSTIFICATION:

The Public Works Department recommends that the Board of Supervisors (BOS) rescind the winning bid to Folsom Lake Ford Res. 91-222, for the Health Department's 4x4 vehicle; they are unable to deliver the vehicle.

We are asking the BOS to approve awarding the bid to DuBose Chevrolet, so that the purchase of the vehicle can be made out of this years budget.

DuBose Chevrolet's bid in the amount of \$17,700 including tax and license is approximately \$868 higher than the original awarded bid. The only difference in the specifications is the Blazer will be a light blue in color. We are asking that you consider this action at this time as the vehicle is only available for the next few days.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Pursuant to proper bid procedures the bids were opened at the appointed time and date and bid was at that time awarded to Folsom Lake Ford, who now cannot provide the vehicle within the necessary time frame.
