RECOMMENDED ACTION AND JUSTIFICATION:

Approve recommended policy on payment to volunteer firefighters when assigned to OES incidents. Recommend the first 12 hours as mutual aid, no payment made. After the first 12 hours, \$16 per hour for each 24 hour shift shall be paid. The balance of reimbursement shall be returned as unanticipated revenue to the County Fire Budget. This recommendation is consistent with the County Volunteer Chiefs letter dated June 4, 1991.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

There is no current policy or action on this item. During the Yosemite Fires in '89 this issue was raised but no policy was established.

1. Pay volunteer firefighters as per system used last year using the CDF state rate on a paid pick-up voucher FC-42, and not receive OES reimbursement.
2. They are volunteer firefighters and receive no pay so no pay should be granted.
