RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes ___ No X)
Public Works recommends that the Board of Supervisors waive the formal bid process and authorize the purchase of three (3) police sedans (bid number PW-90-23) through a "tag on" to the Los Angeles County Police bid award to Sopp Chevrolet. This allows Mariposa County a significant cost savings through a volume discount.

The total cost for the 3 sedans is \$50,370.00 including taxes and new emergency equipment. The existing emergency equipment on the police vehicles to be replaced is several years old but is serviceable and has some useful life remaining.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On August 6, 1991 the Board rejected bids for the 3 sedans based on Public Works recommendations because an insufficient number of bids were received. The lowest bid at that time was \$57,731.31 without emergency equipment.

LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

1. Do not authorize waiver of formal bids and re-advertise for formal bids. Additional costs for administering the bids would result. The bids would likely be much higher than the "tag on" cost.
2. Authorize purchase through the Los Angeles County bids without new emergency equipment. Total cost would be \$43,770.00.


