RECOMMENDED ACTION AND JUSTIFICATION:

That the Board approve the proposal to use Public Administrator/Public Guardian fees now available to enter into a personal services contract to provide for the social work services function of the Public Conservator's Office based on the recommendation of the Superior Court Judge, County Counsel, and Director, Human Services. The position will be equivalent to a Social Worker III regarding qualifications, pay and responsibilities.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board has previously considered and denied the transfer of the Public Conservator function out of the District Attorney's Office. This proposal is an alternative solution to the current staffing and workload problems in the District Attorney's Office.

LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Public Conservator cases will have to be limited to crisis situations only, thereby possibly creating a denial of conservatorship protection to those in need of such services.
