Dear Dr. Cumming:

It is the intent of The Mariposa County Board of Supervisors to apply for funds directly from the Child Health and Disability Prevention (CHDP) Branch. We understand this is necessary in order to continue administering the CHDP Program in Mariposa County. Prior to FY '91 - '92 the CHDP Program in Mariposa County was funded thru our contract with the Local Health Services Section of the Rural Health Division of the Department of Health Services.

We understand our tentative budget allocation for FY '91 - '92 is \$30,036.00 for CHDP and \$4005.00 for EPSDT. We will not apply for Prenatal Care Guidance (PCG) money this fiscal year but would like to consider the option to do so in the future.

Our Health Officer, Dr. Charles B. Mosher, will act as the Director of the CHDP Program in Mariposa County. With the tentative CHDP funds allocated to us, we intend to hire staff to carry out the CHDP Program.

We will be submitting our CHDP Plan soon for your approval. Thank you very much.
