A MAP AMENDMENT TO THE MARIPOSA COUNTY GENERAL PLAN

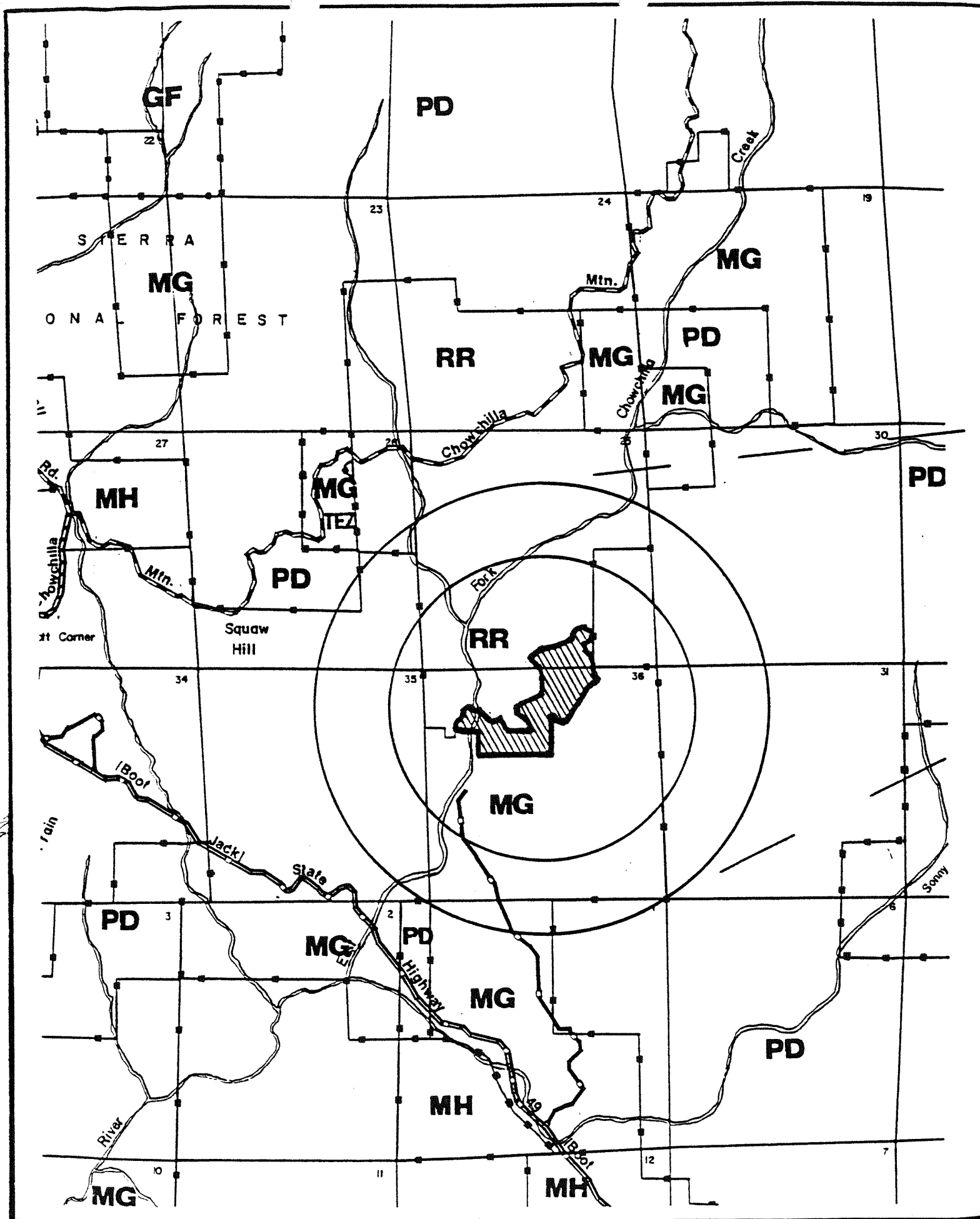
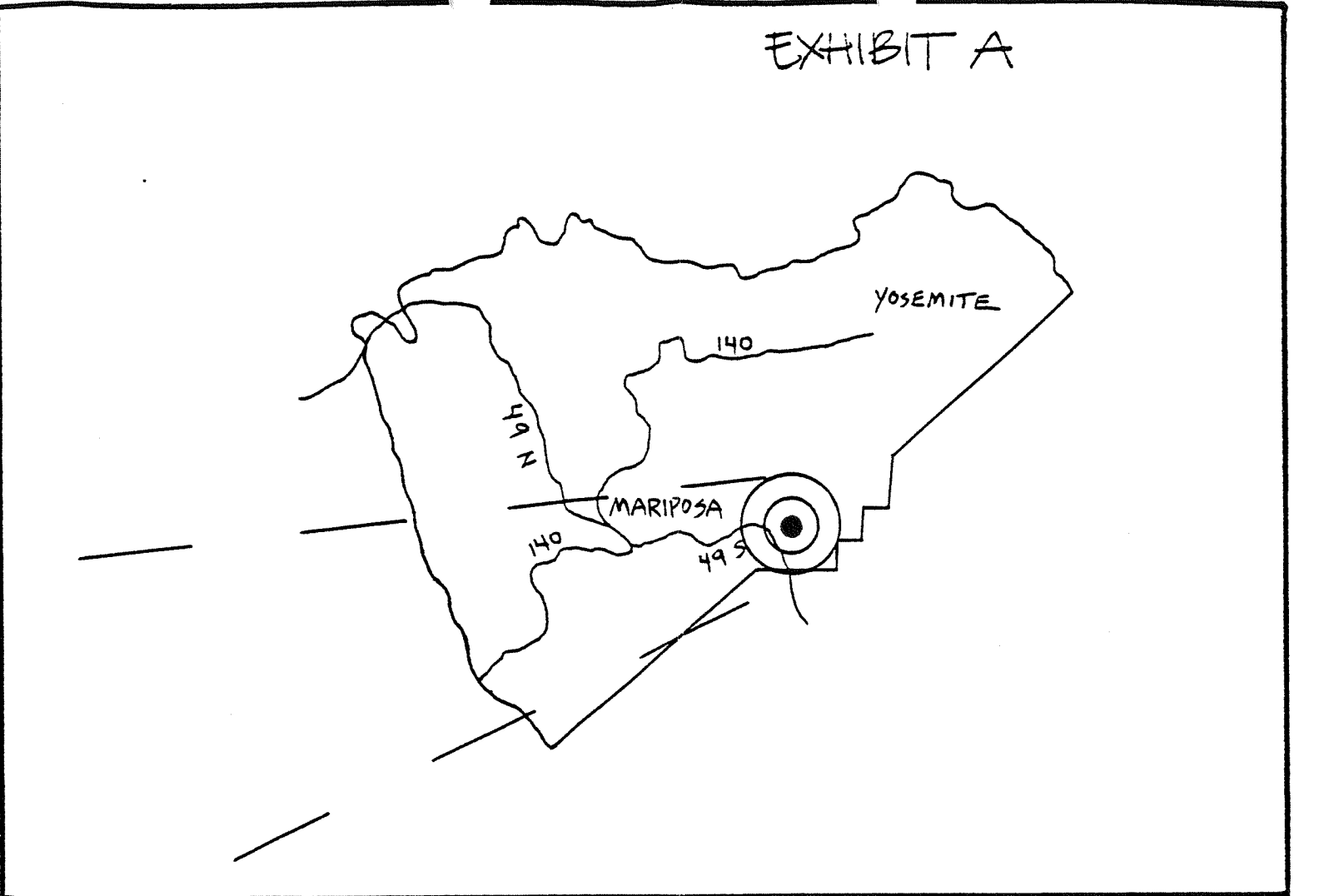
