

MARIPOSA COUNTY RESOLUTION NO. 87-356

A RESOLUTION ADOPTING A MINORITY BUSINESS ENTERPRISE
PROGRAM FOR MARIPOSA COUNTY ROAD DEPARTMENT

WHEREAS, a Minority Business Enterprise Program has been prepared and presented to this Board for its consideration; and

WHEREAS, such a program is mandated by requirements set by the U.S. Department of Transportation as a prerequisite to receiving funds administered through that Department; and

WHEREAS, said program is to be utilized as a guideline in preparing all projects utilizing funds administered by the U.S. Department of Transportation; and

WHEREAS, the proposed program will set a goal of 10.0% Minority Business Enterprise participation with disadvantaged business and female participation on projects limited to Public Works highway projects; and

WHEREAS, the disadvantaged business program is hereby modified to comply with the 1987 Surface Transportation and Uniform Relocation Assistance Act which presumes that women are socially and economically disadvantaged individuals whose participation may be counted in attaining the DBE goal. As such, a separate WBE goal will no longer be used and the terms "DBE and WBE" in the current adopted program shall be understood to mean DBE; and

WHEREAS, the proposed program will apply to all federally funded highway projects.

NOW, THEREFORE, BE IT RESOLVED that the Minority Business Enterprise program be, and hereby is, adopted, and the Road Commissioner is authorized and directed to publish notice requesting comments on the goals in the newspaper of general circulation published in the County of Mariposa.

I. Policy Statement

It is the policy of the Mariposa County Road Department to utilize Disadvantaged Business Enterprise (DBE) and Women Business Enterprise (WBE) in all aspects of contracting to the maximum extent feasible. This policy is fully described herein which constitutes policy and commitment to substantially increase Disadvantaged Business and Women Business Utilization. This policy includes any program activity or facility funded wholly or in part by any U.S. Department of Transportation modal element.

The disadvantaged business program is hereby modified to comply with the 1987 Surface Transportation and Uniform Relocation Assistance Act which presumes that women are socially and economically disadvantaged individuals whose participation may be counted in attaining the DBE goal. As such, a separate WBE goal will no longer be used and the terms "DBE and WBE" in the current adopted program shall be understood to mean DBE.

This Agency, its contractors and subcontractors, which are the recipients of Federal-aid funds, agree to ensure DBE and WBE firms have the maximum opportunity to participate in the performance of contracts and subcontracts. In this regard, this agency and all of its contractors and subcontractors will take all reasonable steps in accordance with 49 CFR 23 to ensure that DBE and WBE firms have the maximum opportunity to compete for and perform contracts.
