

MARIPOSA COUNTY RESOLUTION NO. 87-373

A RESOLUTION AUTHORIZING
REPRESENTATION IN SMALL CLAIMS COURT

WHEREAS, the Districts and Facilities Division of Public Works desires to recover overdue fees through Small Claims Court, and

WHEREAS, the Board of Supervisors of Mariposa County desires to authorize the Manager of Districts and Facilities Division of Public Works, and his successor, and the Account Clerk III, and her successor, as representatives regarding these matters in the Small Claims Court on behalf of the County of Mariposa.

NOW THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of Mariposa County, a political subdivision of the State of California, that the Chairman of the Board is hereby authorized to sign the letter attached hereto as Exhibit "A" and by this reference incorporated herein, designating the Manager of Districts and Facilities Division of the Public Works Department, and his successor, and the Account Clerk III, and her successor, as representatives on behalf of the County of Mariposa in matters involving the collection of overdue fees through the Small Claims Court in the County of Mariposa. Said letter shall then be submitted to the Justice Court of Mariposa County for its records in any actions forthcoming from the Division of Districts and Facilities.
