

MARIPOSA COUNTY RESOLUTION NO. 87-469



PASSED AND ADOPTED by the Mariposa County Board of Supervisors this 15th day of December, 1987, by the following vote:



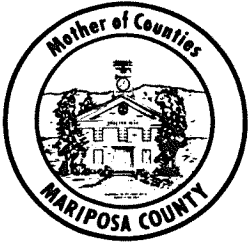


