

MARIPOSA COUNTY RESOLUTION NO. 87-59

RESCINDING MARIPOSA COUNTY RESOLUTION NO. 87-32  
REGARDING FEES FOR PLAN CHECK AND PERMIT ISSUANCE  
WELL, SEWAGE DISPOSAL AND PUBLIC SWIMMING POOL PERMIT

WHEREAS, the MARIPOSA COUNTY BOARD OF SUPERVISORS has adopted Ordinance 676 which added Chapter 15.11, entitled "Permit Fees" to the Mariposa County Code, and

WHEREAS, the Mariposa County Department of Community Services, Building Office, and the Mariposa County Health Department incur plan check file management and other clerical costs involved in the issuance of well, septic and public swimming pool permits, and

WHEREAS, Mariposa County Resolution No. 87-32 was passed on January 27, 1987 and needs to be rescinded and replaced in its entirety with this Resolution;

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of Mariposa County, a political subdivision of the State of California, as follows:

1. Mariposa County Resolution No. 87-32 is hereby rescinded and replaced in its entirety by this Resolution No. 87-59 and shall become effective upon March 9, 1987, which is the date Ordinance No. 676 becomes effective.

2. A plan check fee of Twenty-five Dollars (\$25.00) shall be collected by the Department of Community Services, Building Office, at the time an application for either:  
a. A well permit,  
b. A sewage disposal system permit, or  
c. A public swimming pool permit or spa permit  
is accepted for processing.

3. A permit issuance fee of Twenty-five Dollars (\$25.00) shall be collected by the Department of Community Services, Building Office, at the time an approved permit is issued for any of the items listed in Paragraph No. 2, above.

4. If a dry hole is encountered and one (1) or more additional wells must be drilled in order to produce sufficient water, there shall be no charges in addition to the original charges as described in Paragraphs 1 and 2 above for the additional well or wells. If an additional well is drilled the original permit shall be amended to show the location of the dry hole or holes and the new hole. In addition, the dry hole or holes shall be properly sealed pursuant to County policy.

5. If permit applications for a well and sewage dis-

posals system covering the same structure are received at the same time, then only one (1) plan check fee shall be collected.


