WHEREAS, the Mariposa County Board of Supervisors on March 5, 1985,
passed and adopted the Uniform Conflict of Interest Code; and

WHEREAS, certain amendments have been made updating EXHIBIT "A"
of the Uniform Code;

Supervisors, a political subdivision of the State of California, that EXHIBIT
"A", attached hereto and incorporated herein by reference, shall constitute
the appendix required by Section 18730 of the Uniform Code and may be amended
annually or more often to reflect changes in County staff or organization.





The letters (A, B, C, and D) represent the disclosure categories in the Uniform Code which are referred to in Form 730, Schedules A through H.

DISCLOSURE CATEGORIES

- (A) Any business entity in which the designated employee has a direct or indirect investment worth more than one thousand dollars, \$1,000.
- (B) Any real property in which the designated employee has a direct or indirect interest worth more than one thousand dollars, \$1,000.
- (C) Any source of income, other than loans by a commercial lending institutions in the regular course of business on terms available to the public without regard to official status, aggregating two hundred fifty dollars, \$250, or more in value provided to, received by or promised to the designated employee within twelve months prior to the time when the decision is made.
- (D) Any business entity in which the designated employee is a director, officer, partner, trustee, employee, or holds any position of management.
