Supervisors Smallcombe, Jones, and Long thanked them for their efforts in this regard, and requested hard copies of their calendar of events to distribute throughout the county. Supervisor Carrier extended thanks for their efforts, and discussed the positive effects of the additional outreach into Yosemite National Park. During public comment, Debbie Cook noted that she was a victim of child abuse and discussed the importance of these services.

F. Departmental Presentation

Tony Stobbe/Public Works Director advised that the landfill will be closed next Tuesday because of the Monday holiday advised that Whitlock and Triangle Road are nearly finished; and noted that construction activity has begun on the Courthouse. In response to Supervisor Carrier's inquiry, Mr. Stobbe discussed the sidewalk projects noting that they will have to resubmit for the new federal fiscal year. Supervisors

Jones and Cann extended thanks to Mr. Stobbe for his perseverance in dealing with these issues.

Eric Sergienko/Health Officer handed out a flu clinic poster and pink ribbons for breast awareness month; discussed the incidence of breast cancer and the need for mammograms; noted that the big opening for the Flu Clinic is tomorrow from 2:00 PM to 4:00 PM at the Fairgrounds; and noted that there will also be clinics in other parts of the county as well. He also advised that, theoretically, as of midnight last Friday, he is officially retired from the Navy but he has not yet seen the paperwork. Supervisor Carrier extended thanks for the outreach to outlying areas; and discussed the statistics regarding breast cancer. Supervisor Jones extended thanks for the flyer, noting that he is more than happy to post anything on his website. Dr. Sergienko noted that he will definitely get out the information on the community assessment when it is available.

G. Public Comment on Non-Agenda Items

Jeanetta Phillips cheered on the Courthouse repairs; and extended thanks to the Board, the community, and merchants from the Go West Festival.

Wendy Brown read a statement regarding the proposed Sierra National Monument and noted some of the opposition to it.

Katee Owens noted first speaking to the Board about "Agenda 21" three years ago; spoke in opposition to the proposed Sierra National Monument as she feels that it is part of that agenda; discussed Grape Island off of Massachusetts which the Federal government turned into a bird sanctuary in the 1940s; noted that most of Mariposa County is designated on the Agenda 21 map; stated that there is a rural cleansing going on; and questioned why anyone would want to change anything.

Ruth Sellers noted her appreciation for all of the effort and time that Wendy and Katee put into this project; discussed some bills that Congressman Tom McClintock co-sponsored which would require prior congressional and state approval before any land is designated as a national monument; discussed activities that are no longer allowed in them; and noted that studies by Kenneth Tate of Davis show that grazing does not do damage to the land. Ms. Sellers also discussed her history with Mariposa County, and discussed the need for outdoor recreational areas which conversion to a national monument would eliminate.

Dane Carlson/Chamber of Commerce noted that Visitor Center attendance declined last week, but is still up 17% over last year; extended thanks for the Car Show and noted that, as of yesterday, 105 people have signed up for it; and discussed shuttle buses that will run between town and the Fairgrounds for the event.

Supervisor Cann noted that the monument has been an ongoing effort for 4 or 5 years now; discussed the presidential cycle; noted inquiring into the issue while he was in Washington, D.C. in September; and noted that he was advised that it is not in the administration's game plan right now.

Supervisor Long noted that he spoke about the issue to Rocky Deal, Congressman McClintock's representative, and was assured that it is not going to happen this cycle; but cautioned that diligence on the matter should continue.
